Alice® Ceramic Frit Chemical Durability and Weathering Limited 10-year Warranty

When applied and fired correctly, the Ceramic Frit Enamel will meet the strict chemical resistance levels according to ASTM C724-91 for hydrochloric acid, acetic and citric acid. The Ceramic Frit Enamel is sulfuric acid resistant and has excellent alkali chemical resistance. The UV durability of the produced Ceramic Frit Enamel is guaranteed for 10 years with less than 10% degradation in optical density. The actual performance depends on the following conditions: substrate preparation, ink formulation, firing method and exposure conditions.

Similar inorganic pigments as those used in this ceramic frit process are the constituent of hundreds and thousands years old ancient glass stained products.

In the event that the Ceramic Frit product fails to conform to the Limited Warranty as described above, GGI must be notified in writing of such failure. Liability under this Warranty for defective Ceramic Frit product is limited, at GGI's exclusive option, to replace such Ceramic Frit product without charge F.O.B. nearest shipping point or refund a portion of GGI's selling price for such Ceramic Frit Glass. **Labor costs are not covered by this Warranty.** This warranty does not apply to replacement of Ceramic Frit Glass beyond the Warranty period applying to the original Ceramic Frit Glass. GGI reserves the right to inspect any Ceramic Frit Glass product which is alleged to be defective prior to its removal from the glazing system, installation or fabrication location.

Conditions which will void the Warranty

If any of the following events have occurred, GGI will have no liability under this warranty.

1. **If the Ceramic Frit Glass panes are broken or fractured.**
2. **If the glass that the ceramic frit is applied to is subjected to standing water or other liquids.**
3. **If the Ceramic Frit Glass is damaged or altered by handling, storage, fabrication or installation contrary to guidelines set forth by GANA (Glass Association of North America).**
4. **If the Ceramic Frit painted surface is glazed in a way that will expose the painted surface to exterior elements.**
5. **If the Ceramic Frit Glass is attacked by incompatible glazing lubricants, glazing soaps, incompatible glazing gaskets, glazing sealants, incompatible cleaning fluids, moisture or building runoff, gluing or attachment of any applied films, direct contact with paints, adhesives, solvents or insulation, or exposure to solvent or chemical fumes.**
6. **If the Ceramic Frit Glass was discarded or destroyed.**
