



WARRANTY FLOAT MIRRORS SOLD BY GGI

GGI provides this warranty with respect to its mirror products. No other statement or representation concerning any of GGI mirror products shall be construed as a warranty. This warranty shall extend only to the immediate customer and to no other person. GGI warrants to purchaser that for a period of five (5) years from date of manufacture under normal conditions, its float mirrors will be free of silvering defects resulting from improper production. Such defects include discoloring, black spots and clouding of the silver film.

This warranty will be void if a GGI mirror is:

- Installed with mastic other than an approved mastic or polymer mastic.
- Damaged in handling or installation.
- Subjected to foreign matter put on the back of the mirrors by others, including but not limited to drippings from cleaning for painting walls.
- Subject to requirements outside of normal architectural conditions.
- Exposed to abnormal conditions.

Purchaser's remedy - Purchaser's sole remedy and GGI's sole responsibility with respect to any product which is defective under warranty applicable thereto shall be:

Replacement of such product without charge F.O.B. the customer's place of business, or at GGI's option if replacement is impractical, the refund of the purchase price thereof. In no event shall GGI be liable for any labor expended by other on any such mirrors or for any other costs incurred in the removal of defective mirrors or in the installation or replacement mirrors, or for any other incidental or consequential damages.

GGI reserves the right to have any mirror reported as being defective under this warranty field-inspected by a qualified factory representative and returned to the factory.

This warranty does not apply to replacement units beyond the period of applying to original unit.
